2022/2023 Notice to Parents No. A17 _e Information about Vaccination for COVID-19

Dear Parents,

1. About vaccination for COVID-19

As per announcement of EDB, all schools in the territory when meeting the following requirements, can resume full-day face-to-face lessons commencing 1st November, 2022:

- > All directly-employed staff (teaching and non-teaching staff included) have received 2 doses of COVID-19 vaccines with 14 elapsed days; and
- The number of students having received 3 doses of vaccines with 14 elapsed days amounts to at least 90% of the school qualifiable student population.

In order that the School can make appropriate arrangement for the above to take place, we urge you to update the School with the latest vaccination status of your child on or before 19th September, Monday by returning the completed reply slip with a photo-copy of his/her vaccination record and/or Quarantine Mandate issued by CHP (if applicable) to his/her class teacher. For any queries, please feel free to contact either your child's class teacher or the teacher-in-charge of School Affairs, Ms SIU Man-yee on 25779485 during school hours.

2. About Vaccine Pass

All persons at or over 12 (amended to 5-years-old commencing 9th September) must meet the following requirements of vaccine pass to gain access to designated premises (restaurants, indoor Sports Complex, government market, etc.), only students entering his/her own school can be exempted.

- Comply with the official time line for vaccination, see below for details (subject to updates)

3. Arrangement for Student Vaccination

Vaccination is the most effective precautionary measure against severity of medical condition and death risk in view of COVID-19. The School therefore will arrange for group vaccination at government Community Centre on any school days between late September and early October, details of which is pending on the number of interested students and will be released at due time.

Parents can also choose to surf https://www.covidvaccine.gov.hk/en/ to make appointment for vaccination for your child. Please note that persons under 18 must present a Consent Letter of COVID-19 Vaccination endorsed by parents/guardians for due purpose.

The School takes all effort to upkeep campus hygiene to safeguard students' health so that learning can proceed rest assured. In view of the volatility of COVID-19, the School will pay close attention to announcement of EDB. May we remind you to stay alert for updates released on the School website and myIDChannel Plus app as well as from the government.

Last but not least, we earnestly appeal to your monitoring of your child to stay away from crowds so as to lower the risk of infection. We look forward to resumption of our long-lost normal and healthy lives with concerted efforts of all parties to fight against this pandemic.
