Remarks on the Outdoor Learning Day

1. Students must follow the instructions of teachers, and should not leave the group without seeking prior permission from teachers.
2. Students must bring along their student cards and HKID cards.
3. Students should arrive at the assemble place punctually. Late comers would have to attend detention class on days to follow.
4. Eating or drinking is not allowed on public transport. Students should behave properly and refrain from causing a nuisance to other passengers.
5. Students must pay attention to the instructions by teachers-in-charge, especially regarding activities to engage in designated area, as well as the assemble time and place for return trip.
6. Students must take caution of their personal safety, and must not leave the designated activity area without teacher's permission.
7. Please keep the activity venue clean and tidy.
8. Students are not allowed to barbecue outside the designated activity area. All lit charcoals must be extinguished before leaving.
9. Students are allowed to bring headphones and radios, but please be considerate and keep the volume down.
10. Students must not fish in any reservoir or coastal areas, or enter any catchment channels or streams.
11. Dangerous activities such as mountaineering, cycling and tree climbing are strictly prohibited. Potentially harmful toys like pneumatic guns are also forbidden.
12. Do not approach any wildlife animals. Immediately notify teachers of any dangerous animals on sight.
13. Avoid stirring up any conflict with others. Students should immediately notify teachers if they encounter any harassment or intimidation.
14. In case of accidents, stay calm and immediately notify teachers.
15. Students are advised to dress themselves in plain casual wear, and they should not wear any makeup or flashy accessories. Those violating such rules would be punished.
16. Students absent from the activity due to sickness must submit a medical certificate to the class teacher; while those requesting for leaves other than sickness are required to submit parents' letter beforehand.
17. Those falling sick on the day of the activity must notify the School Office and submit relevant supporting documents upon the first day they return to the school.
18. Students who are late for the assemble time should contact the school and report to teachers-on-duty.
19. The activity will be cancelled should inclement weather occurs, and students have to go back to school as usual. Please browse the school's homepage or make inquiry to the school office at 7:30 a.m. that day for information about any emergency arrangement.
